

ARTICLE 1: CORPORATE NAME: The name of this corporation is Blue Mermaid Pool Service, Inc.

ARTICLE 2: PRINCIPAL OFFICE: The street address of the initial principal office of this corporation is 1356 NW 2 Avenue, No. B12, Boca Raton, FL 33432
