Articles Of Incorporation
Of
Coral West Mortgage Corp.

Article I

The name of the corporation is Coral West Mortgage Corp (hereinafter called the "corporation").

Article II

The address of the principal office and mailing address of the corporation is 2322 SW 67th Ave, Miami, Florida 33155

Article III

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:
