The undersigned Incorporator hereby files these Articles of Incorporation in order to form a Professional Corporation (the "Corporation") under Chapter 607 Florida Statutes and the Professional Service Corporation and Limited Liability Company Act under Chapter 621 Florida Statutes.

**ARTICLE I
Name and Address**

The name of the Corporation shall be **CRAIG R. MYERS, CRNA., P.A.** The principal office of the Corporation shall be located at 1367 Longhill Drive, Apopka, Florida 32712, unless and until changed by resolution of the Board of Directors.

**ARTICLE II
Nature of Business**

The purpose for which the Corporation is organized is to provide personal services rendered by Certified Registered Nurse Anesthetist as permitted under the laws of the United States and the State of Florida.

**ARTICLE III
Stock**
