
ARTICLE VIII



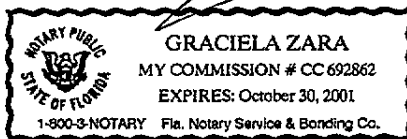


