ARTICLES OF INCORPORATION OF 2000 EXPRESS, INC

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of FLORIDA.

ARTICLE I NAME

The name of the corporation shall be 2000 EXPRESS, INC.

ARTICLE II NATURE OF BUSINESS
