

## **ARTICLES OF INCORPORATION**

### **ARTICLE I - NAME**

The name of this Corporation is City Window Cleaning & Pressure Cleaning, Inc.

### **ARTICLE II - PRINCIPAL OFFICE**

**ARTICLE X - INDEMNIFICATION**


The Corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.




