# ARTICLES OF INCORPORATION OF A-RATED PILOT ESCORTS, INC. (a Florida corporation)



#### <u> ARTICLE I - NAME</u>

The name of the Corporation is **A-RATED PILOT ESCORTS**, **INC.** (hereinafter called the "Corporation").

### ARTICLE II - CAPITAL STOCK
