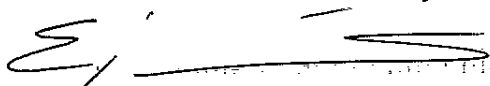

**ARTICLES OF INCORPORATION
OF
F & G SERVICES, INC.**

THE UNDERSIGNED, acting as sole incorporator of **F & G SERVICES, INC.** under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name
