The name of this corporation is MOODY'S CLEANING SERVICE, INC.

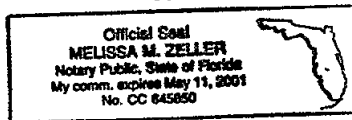




