

The Annual Report Notice was received from each of these companies. My first choice was to file on line as recommended. I was prepared to pay by Mastercard via www.sunbiz.org. When I reached this site, I was referred to the www.floridaucc.com. site to handle the transaction. This site did not offer any familiar options for payment. After phoning the help line, the response was to call back on Monday morning. This would have made the payments past due. So, more effort was made to understand the organization of the web site. After hours of trial and error choosing the options available, the payment was made for Richard E. Kennedy GC, LLC by Mastercard. All information was correctly entered and the confirmation number was forthcoming, when the web site froze. At that time, it was uncertain whether the transaction was complete.

Today, it was confirmed by my credit card company that the payment was accepted, and my account credited. A check is enclosed for the other two corporations. The checks are made out to the Division of Corporations in the amount requested on last year's forms. I have mailed in the request for the proper forms to be mailed to 1834 Buccaneer Circle East. As it will take time to receive these forms, I will call your department upon their receipt to find out how to properly file the reports. Next year, a call will be made to the help line to acquaint myself with the site before novice frustration stands in the way of the process. When the recommended option stated available 24 hours a day - 7 days a week, it was impossible for a new on-line visitor to travel through the site "faster and easier" without assistance.
