ARTICLES OF INCORPORATION OF CT MARKETING, INC.

ARTICLE I

The name of the Corporation is "CT MARKETING, INC."

ARTICLE II

The mailing address of the initial principal office of incorporation is 2900 N.W. 48th Terrace, #209, Lauderdale Lakes, Florida 33313.

ARTICLE III

CT MARKETING, INC. is formed for the following purposes:

- To enter into, perform and carry out contracts and agreements of every kind and nature, with any person, firm, corporation or other entity, and any State, county, municipal or other governmental body, including all boards, bureaus and agencies thereof.
- 2) To carry on any other activities necessary to, in connection with or incidental to the foregoing.
- The provisions of this article shall be construed as purposes and objects, and the matters expressed in each provision thereof shall not be limited in any way, except as otherwise expressly provided herein, by reference to or inference from the terms of any other provision hereof, and shall be regarded as independent purposes and objects. The enumeration of specific purposes and objects shall not be construed to exclude, limit or otherwise restrict in any manner any power, right or privilege given to the Corporation herein by law, or to limit or restrict in any

manner the meaning of the provisions hereof, or the general powers of the Corporation, nor shall the expression of one thing to be deemed to exclude another, although it be of like nature, not expressed.

ARTICLE IV

The Corporation has authority to issue not more than 10,000 shares that together have unlimited voting rights and that together are entitled to receive the net assets of the Corporation upon dissolution.

ARTICLE V

The initial registered office of the Corporation is 2900 N.W. 48th Terrace, #209, Lauderdale Lakes, Florida 33313. The initial registered agent of the Corporation at such office is Margo Carden.
