ARTICLES OF INCORPORATION

OF

THE UNDERSIGNED, acting as incorporator of the professional service corporation ("Corporation") being formed in the State of Florida certifies as follows:

1. **Name.** The name of Corporation is **DAVID D. HOLLAND, CPA, P.A.**
2. **Purpose.** Corporation is formed for the following purposes:
  - a. To engage in the specific business of the practice of the profession of certified public accounting through individuals licensed under the laws of Florida to practice public accounting in Florida.
  - b. To purchase or otherwise acquire, hold, own, maintain, improve, operate, mortgage, sell, convey, lease, sublease, or otherwise deal in and dispose of personal and real property of every kind, character, and description in furtherance of Corporation's professional business.
  - c. To enter into contracts of all kinds in furtherance of Corporation's professional business.
  - d. To borrow money with or without security in furtherance of Corporation's professional business, and to make, indorse, execute, and issue those instruments for the payment of money that are necessary to evidence Corporation's borrowings.
  - e. To invest Corporation's funds in real properties, mortgages, stocks, bonds, or any other types of investments, and while the owner or holder of any real properties, mortgages, stocks, bonds, or other type of investments, to receive, collect, reinvest, and dispose of the interest, dividends, and income arising from such property, and to possess and exercise all the rights, powers, and privileges of ownership, including all voting powers of any stocks owned.
  - f. To establish and carry out pension, profit-sharing, share-bonus, share-purchase, incentive, and benefit plans, trusts, and provisions for any or all of Corporation's Directors, officers, and employees.
  - g. Paragraphs 2(a) through 2(f) shall be construed as enumerating both objects and purposes of Corporation, and the enumeration of specific purposes shall not be held to limit or restrict in any manner the purposes of Corporation otherwise permitted by law.

**h.** To exercise all of the powers now or hereafter conferred by the Florida Law upon corporations formed thereunder, subject to any limitations contained in the Florida Law or in accordance with the provisions of any other statute of Florida.

**3. Address.** The office of Corporation is to be located 444 Seabreeze Boulevard, suite 230, Daytona Beach, Florida 32118.

**4. Capital Stock.** The aggregate number of common shares that Corporation shall have authority to issue is One Hundred Thousand (100,000) Common Shares, which shares are to have a par value of One Dollar (\$1.00) per share.

**5. Ownership Only by Qualified Persons.** The shares of capital stock of Corporation shall be issued and transferred (other than by operation of law or court decree) only to individuals who are authorized to practice as a certified public accounting in the State of Florida. No transferee of shares of capital stock of Corporation by operation of law or court decree may vote such shares for any purpose whatsoever except as permitted by the laws of Florida.

**6. Names and Qualifications of Shareholders.** The name, residence, and license or certificate number of the individual who is to be the original shareholders, Directors, and officers of Corporation are:

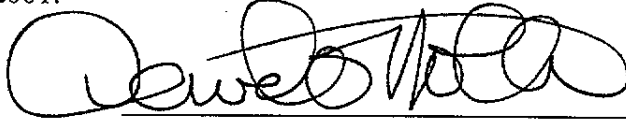

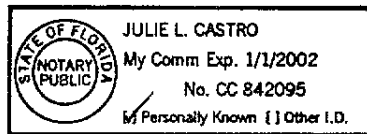

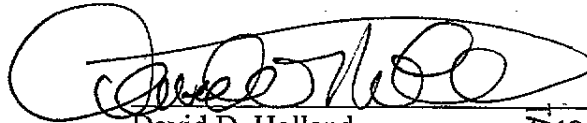
