

**ARTICLE I**

**NAME:** The name of this Corporation is GETFORD AND GETFORD, INC., and its address is 1623 Getford Road, Eustis, Florida 32726.

**ARTICLE II**

**DURATION:** This Corporation shall exist perpetually.

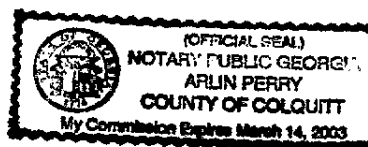
