ARTICLE 1 - Name

The name of the corporation is: Mary Ross, P.A.



ARTICLE X – Indemnification

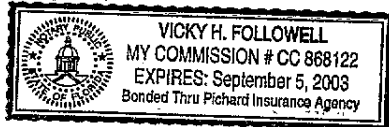
This corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.


