ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is:

ARTICLE X - SECTION 1244

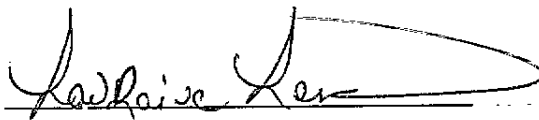

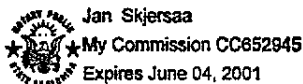
