The undersigned subscribers to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida, effective April 15, 2001.

ARTICLE I

The general nature of this business to be transacted by this corporation is all forms of real estate sales, management, rental, etc., including commercial and residential, related services, and:

- 1. To engage in any activity or business permitted under the laws of the United States and of this State.
