THE UNDERSIGNED, acting as sole incorporator of QUANTUM ENGINEERING & RESEARCH, INC., under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I**

**Name**

The name of the corporation is QUANTUM ENGINEERING & RESEARCH, INC.


