The number of shares of stock is: 200

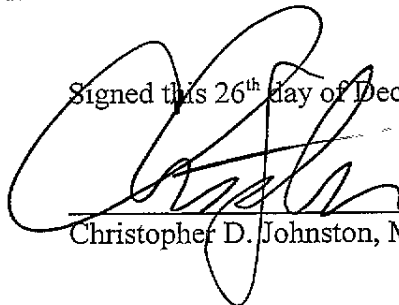
2. DATE OF ADOPTION
