**ARTICLE I - NAME**

The name of this corporation is:

**ARTICLE II - BEGINNING OF CORPORATE EXISTENCE**

The existence of this corporation shall commence on the date these Articles are filed with the Secretary of State. This corporation is to exist perpetually.

**ARTICLE III - PURPOSE**


**ARTICLE VIII - INDEMNIFICATION**

**ARTICLE IX - AMENDMENT**

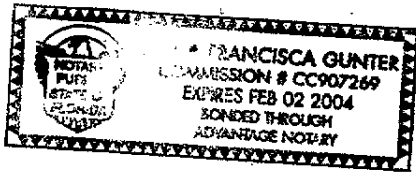
The Articles of Incorporation may be amended, changed, altered or repealed in the manner now or hereafter prescribed by the Florida Statutes.
