ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF MY GOLF ANGELS, INC. (P01000039736) (Document Number of Corporation)

Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:

1. Article IV of the Articles of Incorporation of the Corporation is amended to read as follows:

The street address and principal office of the Corporation shall be 562 NW 45th Way, Delray Beach, FL 33445.

The name of the Corporation's registered agent is Rutherford, Mulhall & Wargo, P.A., 2600 N. Military Trail, Fourth Floor, Boca Raton, FL 33431.

2. Article V of the Articles of Incorporation of the Corporation is amended to read as follows:

The number of Directors constituting the Board of Directors of this Corporation is one. The number of directors may be either increased or decreased from time to time as provided in the Bylaws of the Corporation, but shall never be less than one (1). The Directors may serve from time to time and may, by resolution, fix the number constituting the Board of Directors and may also name the persons to fill vacancies on the Board of Directors created by an increase in the number of Directors which occurs between annual meetings.
