ARTICLE I - NAME

The name of this corporation is: **FULL MONTE ENTERPRISES, INC.**



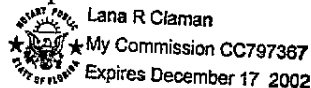
