X. AMENDMENTS

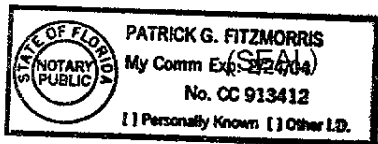




