ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is SPACICS, INC., and the principal address is 8176 Nature's Way, Unit 24, Bradenton, FL 34202.

ARTICLE II - REGISTERED OFFICE AND AGENT

The address of its registered office in the state of Florida is 8176 Nature's Way, Unit 24, Bradenton, FL 34202. The name of its registered agent at such address is Samantha Hall.

ARTICLE III - PURPOSE

The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the General Corporation Law of the state of Florida.

The incorporator is Dennis G. LaPointe, whose mailing address is 17757 U.S. Highway 19 North, Suite 500, Clearwater, FL 33764.


