### ARTICLES OF INCORPORATION

# ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is SPACICS, INC., and the principal address is 8176 Nature's Way, Unit 24, Bradenton, FL 34202.

# ARTICLE II - REGISTERED OFFICE AND AGENT
