#### ARTICLES OF INCORPORATION

#### ARTICLE 1 - NAME

The name of this corporation is Norland Heights, Inc.

#### ARTICLE II - DURATION

The duration of the corporation shall be perpetual and shall commence upon the signing and acknowledging of these Articles.
