The undersigned incorporator, for the purpose of forming a corporation under Florida Business Corporations. Act. hereby adopt(s) the following Articles of Incorporation.

ARTICLE I

- To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, or obligations of, other domestic or foreign corporations, associations, partnerships, or individuals, or direct or indirect obligations of the Unites States or of any other government, state, territory, governmental district, or municipality or of any instrumentality thereof;
- To make contracts and guarantees and ineur liabilities, borrow money at such rates of interest as the corporation
