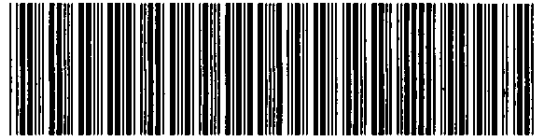



The name of this corporation is CELL-TEL GOVERNMENT SYSTEMS, INC.


ARTICLE II
