The undersigned hereby makes, subscribes, acknowledges, and files this certificate for the purpose of becoming a corporation for profit under the laws of the State of Florida:

ARTICLE I

Name

The name of this Corporation shall be EASY MAIL OF TALLAHASSEE, INC.

ARTICLE II

Purpose
