ARTICLES OF INCORPORATION

CAPE TEK MARKETING, INC.

The undersigned Incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following articles of Incorporation

ARTICLE I ~ NAME

The name of the corporation shall be **CAPE TEK MARKETING, INC.**

ARTICLE II ~ PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation shall be 106 Peirce Avenue, Cape Canaveral, Florida 32920

ARTICLE III ~ CAPITALIZATION

The number of shares of stock that this corporation is authorized to have outstanding at any one time is one hundred in a single class, without par value.

ARTICLE IV ~ CORPORATE DURATION

The Corporation shall commence existence on April 15, 2001 and shall have perpetual existence.

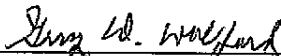
ARTICLE VII ~ DIRECTOR

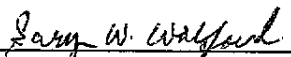
