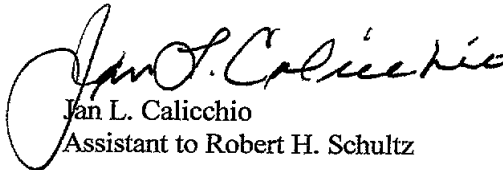

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

**ARTICLE I: NAME**

The name of the corporation shall be Arbuckle Bail Bonds, Inc. and the principal place of business of this corporation shall be 533 13th Street West, Bradenton, FL 34205 and the mailing address of the corporation shall be 533 13th Street West, Bradenton, FL 34205.

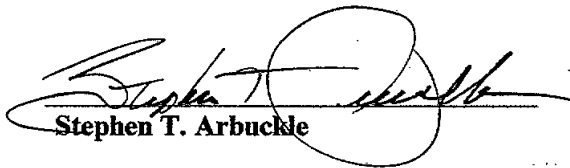

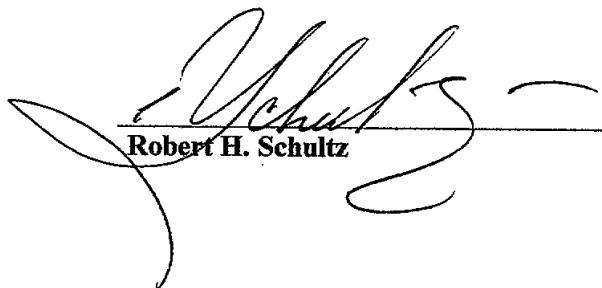
