I, the undersigned, hereby make, subscribe, acknowledge and file with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a business organization for profit in accordance with the laws of the State of the State of Florida.

**ARTICLE I**

**Existence of Corporation**

This corporation shall have perpetual existence.

- (d) The corporation may engage in the transaction of any and all-lawful business for which corporations may be incorporated under the laws of the State of Florida.

#### **ARTICLE V** **Capital Stock**

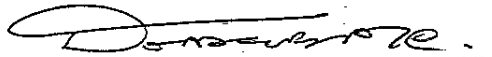
