ARTICLES OF INCORPORATION

OF

TEK CORP

The undersigned, desiring to form a corporation under Chapter 607, the Florida General Corporation Act, does hereby certify:

Article 1 - Name

The name of this corporation (which is hereinafter called the "Corporation") shall be:

TEK Corp

and the principal place of business will be 1102 East Nursery Rd., Santa Rosa Beach, FL 32459 and the mailing address will be 1102 East Nursery Rd., Santa Rosa Beach, FL 32459.

Article 2 - Commencement and Duration

The commencement of this corporation's existence shall be at the time of the filing of these Articles of Incorporation by the Secretary of State. This corporation's duration shall be perpetual.
