ARTICLES OF INCORPORATION

OF

M. A. FUNDING, INC.



ARTICLE I - NAME AND ADDRESS

The name of this corporation is M. A. FUNDING, INC. (the "Corporation"). The address of the principal office and the mailing address of the Corporation is 1800 N. W. 69th Avenue, Suite 201, Plantation, Florida 33313.

<u>ARTICLE II - PURPOSE</u>

The Corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE III - CAPITAL STOCK

The aggregate number of shares which the Corporation shall have authority to issue is One Thousand (1,000) shares of common stock, all of which are to have a par value of One Cent (\$.01) per share.
