





Addendum

Sheila D. Patterson and Jewel Johnson have mutually agreed the following:

- 1) The president and secretary of said Corporation shall be Sheila D. Patterson
- 2) The vice president and treasurer of said Corporation shall be Jewel Johnson.
- 3) The percentage of ownership of said Corporation is as follows: Sheila D. Patterson, 60%; Jewel Johnson, 40%.
- 4) Equal percentage (50/50) of ownership between Patterson and Johnson of said Corporation shall be issued upon an appropriate investment by Jewel Johnson.
- 5) Jewel Johnson shall make an initial \$3,000.00 cash investment and an investment of her public relations and marketing services to the said Corporation. The "services" investment shall be made in respect to the 1998-1999 value of the newspaper (formerly Pages of Color-Entrepreneur Digest) that said Corporation now owns. A determination of the newspaper's, now renamed The South Florida Entrepreneur Digest, 1998-1999 value shall be made when funds are available to conduct the valuation.
- 6) The corporation has been developed to primarily conduct the business of publishing The South Florida Entrepreneur Digest and, secondarily to offer marketing, public relations and event planning services.
