

ARTICLES OF INCORPORATION
OF

The undersigned natural person, acting hereby as Incorporator for the purpose of forming a Professional Service Corporation for profit under the provisions of Chapter 607, Florida General Corporation Act and Chapter 621, Florida Professional Service Corporation AND Limited Liability Company Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME OF CORPORATION

The name of this corporation shall be FRANK LACHOWSKY, M.D., P.A.

ARTICLE II - PURPOSE

The purpose of the corporation is to engage in the practice of medicine and the rendition of medical services as well as to engage in any other business permitted under the laws of the State of Florida.

ARTICLE III - CAPITAL STOCK

The corporation shall be authorized to issue One Thousand shares (1,000.00) of common stock at \$1.00 per share par value and shall be issued only to a duly licensed professional in good standing who has paid consideration in lawful money, property, labor or services.

ARTICLE IV - PRINCIPAL OFFICE

The initial street address for the principal office of the corporation shall be 2734 Sunrunner Lane, Gulf Breeze, Florida 32561. The initial mailing address shall be 3829 State Street Drive, New Orleans, LA 70125.

ARTICLE V - INITIAL REGISTERED OFFICE AND REGISTERED AGENT

The initial registered office of the corporation shall be 4300 Bayou Boulevard, Suite 7, Pensacola, Florida 32503 and the initial registered agent shall be Robert N. Heath, Jr.

ARTICLE VI - INCORPORATOR

ARTICLE VII - BOARD OF DIRECTORS


