**CORPORATE NAME**



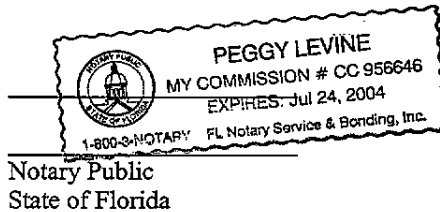


