ARTICLES OF INCORPORATION

of

William J. Trappen, P.A.**ARTICLE I. NAME**

The name of this professional association shall be William J. Trappen, P.A.

ARTICLE II. COMMENCEMENT & DURATION

The commencement of this professional association's existence shall be at the time of the filing of these Articles of Incorporation. This professional association's duration shall be perpetual.

ARTICLE III. SPECIFIC PURPOSE

This professional association is being organized for the purpose of engaging in the practice of law under the laws of Florida and the United States of America.

ARTICLE IV. CAPITAL STOCK

This professional association shall have the authority to issue 100 shares of common capital stock at a par value of \$1 per share.

ARTICLE V. PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash by this professional association of any shares of new capital stock of the same kind, class, or series, as that which the shareholder already holds, shall have the preemptive right to purchase a pro rata share thereof (as nearly as may be done without the issuance of fractional shares) at the price at which such shares are offered to others.

ARTICLE VI. TRANSFER RESTRICTIONS

No shareholder shall have the right to sell, assign, pledge, encumber, transfer, or otherwise dispose of any shares of the capital stock of this professional association, without first offering such shares for sale to this professional association at the net asset value thereof. Such offer shall be in writing, signed by the shareholder, sent by registered or certified mail to this professional association at its registered office address, and open for acceptance by this professional association for a period of fifteen days from the date of mailing. If this professional association fails or refuses, within such period, to make satisfactory arrangements for the purchase of such shares, the shareholder shall have the right to dispose of such shares without any further restrictions.

On the death of any shareholder, this professional association shall have the right to purchase any shares of the capital stock of this professional association owned by the shareholder immediately prior to the shareholder's death, on the terms set forth above, and this provision shall be binding upon the personal representative of the shareholder.

Each stock certificate issued by this professional association shall carry the following legend:

"These shares are held subject to certain transfer restrictions imposed by this professional association's Articles of Incorporation, a copy of which is on file at this professional association's principal office."
