ARTICLE I-NAME

The name of this corporation is TELE-PARADIGM CORPORATION

ARTICLE II-DURATION

This corporation shall have perpetual existence commencing at the filing of the Articles of Incorporation with Department of State.

ARTICLE XIV-SHAREHOLDERS QUORUM AND VOTING


