


ARTICLES OF INCORPORATION

The undersigned, GEORGE BUDDY PRESSLEY, does hereby execute and acknowledge the following Articles of Incorporation:

PAS SPORT CONSULTANTS, INC.

2. The general purpose for which the corporation is initially organized is the transaction of any and all lawful business for which corporations may be incorporated, including providing consulting services on summer camp programs under Chapter 607.164 of the Florida Statutes.
3. The aggregate number of shares which the corporation shall have the authority to issue is one thousand (1000) shares of One Dollar (\$ 1.00) par value common stock.
4. The street address of the corporation's initial registered office is 4 Mendota Lane, Fort Lauderdale, FL 33308. The name of the initial resident agent is George Buddy Pressley. The address of the principal business office is 4 Mendota Lane, Fort Lauderdale, FL 33308.
5. The corporation shall have no directors. The powers and duties conferred or imposed upon the Board of Directors by Chapter 607, Florida Statutes, shall be exercised or performed by the stockholders.
