

I, the undersigned subscriber to these Articles of Incorporation, being a person of legal age, do hereby desire to form a corporation under the laws of the State of Florida and do hereby adopt the following Articles of Incorporation.

ARTICLE I

The name of this corporation is Y C T C, INC.

The duration of this corporation shall be perpetual. The date and time of the commencement of the corporate existence shall begin April 30, 2001. or the date of incorporation whichever is earlier. *[Signature]*

ARTICLE VI


The initial registered agent of this corporation shall be H. STEVEN JOHNSON III, 4555 Dardanelle Drive, Orlando, FL 32808-3831.






