ARTICLE I

Corporate Name and Principal Office

The name of this corporation is E & A CONSTRUCTION SERVICE, INC.

Commencement of Corporate Existence

The corporation shall come into existence on the date of subscription and

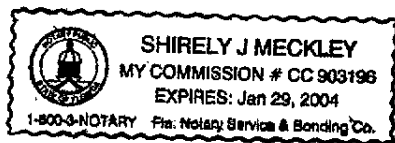
