ARTICLES OF INCORPORATION OF STEEL MANAGEMENT GROUP, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be Steel Management Group, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address shall be 3325 Addison Drive, Pensacola, Florida 32514.

ARTICLE III PURPOSE

The purpose of this corporation is to engage in any activity or business permitted under the laws of the United States or the State of Florida.

ARTICLE IV DURATION

This corporation shall exist perpetually, commencing upon the date of filing these Articles of Incorporation with the State of Florida.

ARTICLE V CAPITAL STOCK
