

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

PANTHER TELECOMMUNICATIONS CORPORATION

The address of the principal office of this corporation shall be 6991 N.W. 82ND Avenue, Bay 11, Miami, Florida 33166 and the mailing address shall be the same.

ARTICLE II. NATURE OF BUSINESS
