

Dear Florida Department of State Division of Corporations,

Attached you will find four items. The first item is an application of re-instatement for Fun Fitness and Dance Center Inc. This Corporation was dissolved because the corporation did not generate UBR reports.

Second, you will find the original certificate that was given to myself by the attorney that applied, on my behalf, for the corporation.


Third, is a document sent to me by Escambia, County. This document proves that there have been address confusion and mail delivery problems. The property, which I purchased in 2001, unbeknown to me, had two legal addresses. I used the Fairfield Drive address, the only address to for which I had knowledge, while the post office gave my location a Jackson Street address. Because of this, mail delivery was scarce as several mail delivery personal did not know the dual address problem, nor did I know of the situation. This has created numerous problems including Uniform Business Reports not reaching me by mail. This matter was only brought to my attention after months of investigation and stress. To make matters worse, your organization had incorrect address information, having my address on South Fairfield instead of North Fairfield, making delivery virtually impossible.

The fourth included item is another letter from Escambia, County showing the correction of said problem. 598 N. Fairfield Drive is now the designated address for my business.

I regret this error, for myself and for the State of Florida. The situation has been remedied and will no longer occur. I humbly ask you to please waive the full re-instatement cost, accept the \$308.75 fee, and reinstate Fun Fitness and Dance Center, Inc. (please note, the \$8.75 is the fee for the requested certificate of status).

Also, please note that the proper address is 598 North Fairfield Drive, Pensacola, FL 32506
