**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of Larry Hanan Enterprises, Inc., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is:

ARTICLE III. COMMENCEMENT OF EXISTENCE

ARTICLE IV. PURPOSE

The corporation is organized to engage in any activity or business permitted under the laws of the United States and Florida.

ARTICLE V. AUTHORIZED SHARES

The maximum number of shares that the corporation is authorized to have outstanding at any time is 10,000 shares of common stock having a par value of \$.01 per share.


Pursuant to Chapter 48.091, Florida Statutes, the following is submitted:
