Your office recently sent me a Certificate of Administrative Dissolution and an Application for Reinstatement related to my corporation.

Not knowing exactly what this was, or why my corporation was dissolved, I asked my accountant. He explained to me that I should have paid the annual renewal fee (of \$150.00) on or before May 1, 2002 to keep my corporation active in your system. He explained that I should have received an original Uniform Business Report from your office in January or February. He explained to me what it looked like.

I do not recall ever receiving such a form from your office.

During the first part of 2002, I moved my office from 102 West Edney in Crestview FL to a rented office in Destin FL. Because of this move and because another company also operates from that office, much of my mail was mishandled and did not get forwarded correctly.

Also, I moved my residence from Crestview to Destin during the same time.

In consideration of the fact that I did not receive your original UBR form earlier this year, I respectfully request that you waive the reinstatement fee of \$600.00.

I have completed the reinstatement application and enclosed it, and a check in the amount of \$150.00, with this letter.
