NAME OF CORPORATION ENTITY: The name of the corporation shall be:

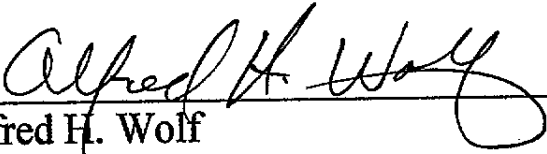
