ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Laws of the State of Florida, adopt the following Articles of Incorporation.

ARTICLE I - NAME

The name of this corporation is RAJ BUILDING CONCEPTS, INC.

ARTICLE II - DURATION

This corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this corporation is to sell building products, wholesale, retail to the public and engage in any activities, conduct any business or businesses permitted under the laws of the United States, the State of Florida, or any, state in which it may then be currently registered or conducting business.

#### ARTICLE IV - CAPITAL STOCK

The total number of shares that the corporation has authority to issue and have outstanding at any time is 1000 shares of a single class of common stock having a par value of one dollar (\$1.00) per share.

#### ARTICLE V - PREEMPTIVE RIGHTS

The holders of the common stock of this corporation shall have preemptive rights purchase at prices, terms, and conditions that shall be fixed by the Board of Directors, those shares of the common stock of this corporation which may be issued from time to time for money, property, or past services in addition to that stock authorized and issued by the corporation. The preemptive right of any holder is determined by the ratio of the authorized and issued shares of common stock held by the holder and all shares of common stock currently authorized and issued.

#### ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT AND PRINCIPAL PLACE OF BUSINESS

The initial registered office and principal place of business of the corporation is 6850 Cedar Ridge Circle, Milton, Florida, 32570 and the initial registered agent of this corporation at such office is ALAN ISAACSON, who, upon accepting this designation, agrees to comply with the provisions of the


Florida Statutes with respect to keeping an office open for service of process.

ARTICLE VII - INITIAL BOARD OF DIRECTORS

The initial Board of Directors shall consist of three (3) members. The number of directors may be increased or decreased from time to time by vote of the stockholders, but in no case shall the number of directors be less than the minimum number allowed by law, nor more than five (5).
