

- To have a corporate seal, which may be altered at will, and to use it, or a facsimile of it, (c) by impressing, or affixing it or in any other manner reproducing it;
- To purchase, receive, lease, or otherwise acquire, own, hold, improve, use, and otherwise (d) deal with real or personal property or any legal or equitable interest in property wherever located;
- To sell, convey, mortgage, pledge, create a security interest in, lease, exchange, and otherwise dispose of all or any part of its property;
- To lend money to, and use its credit to assist, its officers and employees to the full extent permitted by law,

- (r) To make payments or donations or do any other act not inconsistent with law that furthers the business and affairs of the corporation;
