# ARTICLES OF INCORPORATION ADAMS SANITATION, INC.

The undersigned, acting as incorporator of a corporation for profit under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

#### ARTICLE I.

The name of this corporation is ADAMS SANITATION, INC. and the principal place of business shall be 477 Marten Lane Holt, FL 32564.

DURATION: The corporation shall exist perpetually. Find ARTICLE III.

PURPOSE: The purpose or purposes for ganized is 1 **PURPOSE:** The purpose or purposes for which this corporation is organized is to engage in operating a garbage pickup and disposal business, and/or any activity or business permitted under the laws of the United States and the State of Florida. shall be a general purpose corporation. Its goals and purposes shall be determined by its directors. The corporation may hire such employees as may be necessary or desirable to accomplish its purposes, and may hold such licenses as are necessary or convenient for corporate purposes.

PREEMPTIVE RIGHTS: Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro-rata share thereof (as nearly as maybe done without issuance of fractional shares) at the price at which it is offered to others.
